

LOCATION AND SPECIFICATIONS

- Trial Club: GUIDES CANINS inc
- Trial location: This test will be held at GUIDES CANINS 1200A montée Poirier, Saint-Lazare, indoors, in the old building <http://www.guidescanins.com/en/facilities/directions/> Open 8 a.m. to 9:30 p.m. This facility is not handicapped accessible.
- Lodging & food accommodation: <http://www.guidescanins.com/en/trials/spring-competition/>
- Rain or shine.
- This trial is being held under the Barn Hunt Association Rules (www.barnhunt.com).
- This trial will take place at GUIDES CANINS inc. The BHA ring and blind (10 ft x 16 ft) will be indoors, with a maximum blind of 5. Restrooms are available in the main building. The footing for the ring is rubber matting.
- Crating will be outdoors. Bring food, drinking water, dog water, a crate and outdoor shade and shelter for you and your dogs.
- Crating area is outside, located just in front of the building where the BHA trial will occur. It is in a sand/grass area with a few trees. Tents for shade/rain coverage are strongly suggested along with camping chairs for seating. Don't forget to bring water for your dogs!
- The BHA Trial area will be located in the 'old' center area. Crating will take place in the front of this building outdoors as shown in the map.





ELIGIBILITY

- This trial is open to all dogs, purebred and non purebred, that have a BHA ID number. (<http://www.barnhunt.com>) You cannot submit an entry without a valid barn hunt number.

REGISTRATION, FEES & PAYMENTS

- Mail entries to: GUIDES CANINS inc, % Chelsea Du Jardin, 1200A montée Poirier, Saint-Lazare, QC J7T 0L7.
- You can also register via the electronic form: DOGSHOW.CA If you have trouble, call us at 450-424-1469. Waiver/participation agreement must be filled and signed in order for entry to be valid. Cheques are also accepted made payable to Guides Canins Inc and sent to GUIDES CANINS inc, % Chelsea Du Jardin, 1200A montée Poirier, Saint-Lazare, QC J7T 0L7.
- Entries are limited. We reserve the right to refuse any entry. Judges are limited to 8 hours of judging and a maximum run value, which will require the club to limit entries accordingly. **Late and/or Day of Show entries are not a guaranteed entry and will be accepted only up to judging limits. Confirmations will not be sent for late entries.*
- ATTENTION FOREIGN EXHIBITORS: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted. If you pay by personal American cheque, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. If entering via paper entry you can fill out the credit card information at the bottom of the form or wait to receive an invoice via our Propet system where you are able to pay via credit card, an account will be created and a password will be generated directly to you. A valid rabies certificate is required to bring a dog into Canada. Please refer to the government website for any other restrictions.
- The cost of entries is \$34.50+tx/run for Novice, Open, Senior, Master and Crazy 8's and \$17.20+tx/for the instinct class. It will be possible to register after the closing date or on site, if there is still room. The cost for late entries, and same day entries (if available), will be \$40.50+tx)/class (Novice, Open, Senior, Master and Crazy 8s) and \$21+tx/ for the instinct class. FEO registrations are not accepted.
- There shall be no refunds, cancellation or changes after the closing date or in the event a dog and/or handler are dismissed from competition regardless of the reason for such a dismissal or in the event of inclement weather.
- Participants canceling before the closing date will obtain a refund (by check or on their credit card).
- If a person withdraws after closing and no one is on a Wait List to fill their spot their entry is not eligible for refund.
- A refund will be issued for dogs and handlers that are injured, providing that they send a veterinarian or a doctor note and that the trial secretary is advised within 24 hours of the start of the trial.
- Any refund issued will be minus the credit card or paypal fee.
- A \$20 fee will be charged for NSF checks and refused credit cards.

PROCEDURE

- REGISTRATION: Trial Secretary Desk and check-in opens at 8:00 am.
- JUDGING ORDER: The order of testing in a class will be the order in which entries are received. Dogs will be run in height order, except when multiple entries of the same handler require separation when possible. Dogs will be staged in groups of 5 max.
- TENTATIVE RUNNING ORDER (all days): **Trials will run concurrently.** General **briefing is at 8:15 am.** There will be two rings running simultaneously in the inside building with a partition dividing the room as to take away any visual distractions from other ring. Ring 1 will always hold Novice1 (at 8:30 a.m.) followed by Novice 2, Open 1, Open 2, Senior 1, Senior 2. Ring 2 will hold Instinct (at 8:30 a.m.) followed by Crazy 8, Master 1 and Master 2. The judges will alternate between rings each day. Those running Instinct will begin with the Instinct run.
- Dogs earning a title in Trial 1 may be moved up to the next class for the second trial or perform a lateral move. Move-ups and lateral moves will be accepted up until 10 minutes after the conclusion of the relevant Trial 1 class. You must complete the Move-up/Lateral form available at the secretary's table. Move downs can only be made from day to day, not from trial to trial.
- The running order will be sent by email prior to the event.
- The results will be posted on site and sent by email at the end of the event.
- GUIDES CANINS inc will award placement ribbons for first through fourth place in Novice, Open, Senior and Master classes for combined heights for A levels and B levels. Ribbons will be awarded for all qualifiers in the regular classes. Dogs that earn a Barn Hunt title, RATI, RATN or higher will receive a title rosette. High in class rosettes will be offered for all A levels and Master B (Champion).
- Height divisions: Dogs are divided into groups by their shoulder height. Small 15" and under Medium 15.1" to 22", Large over 22".
- Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification to do so is found by the judge and/or trial committee.
- More details to come with your confirmation email.
- *Due to there being multiple sport trials, competitors are expected to make their BHA schedule a priority. We cannot guarantee that rescheduled dogs will not be blinded with bitches in season, and once the last blind for a course is closed we will not create a new blind for late dogs. No refunds are offered for missed runs.*

In consideration of the acceptance of this entry by GUIDES CANINS, (the "Organizer") and the opportunity to have the Dog participate, compete in and/or be judged at this event or trial (the "Event"), I, the reader, agree as follows:

I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs. I agree that the Organizer for the Event may refuse my entry for any reason that it deems to be sufficient.

I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests (my "Related Parties"), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue the Organizer,, GUIDES CANINS inc, The BHA, or any of their directors, executives, committees, representatives, employees, volunteers or agents (the "Personnel"), BHA LLC approved judge judging at this event and the Sanctioned Organizations for any injury, death, property damage or other loss that I or my related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
